1 Respective responsibilities of the body and the auditor

2 External auditor report 2020/21

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the prior year, the smaller authority was exempt from our review, thus we have not reviewed any evidence to support the prior year comparatives on the AGAR.

The Annual Internal Audit Report has been completed on form AGAR Part 3PM, which is designed for use by parish meetings only. Thus, the internal auditor has not given a conclusion on internal control objective G regarding employee costs.
